1. The Islamic Republic of Pakistan has received a financing from Asian Development Bank (ADB) towards the cost of **Balochistan Water Resources Development Sector Project**. It is intended that part of the proceeds of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Balochistan Agriculture and Cooperatives Department** (“the Employer”) represented by the Deputy Project Director, Project Implementation Office (PIO), Balochistan Water Resources Development Sector Project invites sealed bids from eligible Bidders for the **Command Area Development Works- Karkh Valley Development, Mula River Basin** (“the Works”). The Works mainly comprise:

Construction of Open Channel Lined Water Courses with Ancillary Structures. The construction period of the Contract is 12 months.

3. **National Competitive Bidding** will be conducted in accordance with the ADB’s [Single Stage – One Envelope](#) bidding procedure and is open to all eligible Bidders as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - Participation in at least one (1) contract that has been successfully or substantially completed within the last ten (10) years and that is similar to the proposed works i.e. construction of water courses and ancillary structures, where the value of the Bidder’s participation exceeds PKR 80 million.
 - Minimum average annual construction turnover of PKR 322 million, calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.
 - Must have valid PEC registration in category C-4 or above along with PEC Specialization Codes CE-04 (Irrigation) and CE-10 (General Civil Engineering Works).

The completed qualification criteria are described in the Bidding Document.
